**Subject:** Planned Commission/ACCJC Listening Sessions

In late August, Chancellor Brice Harris released the California Chancellor's Office Task Force on Accreditation Report to the public. In response to that report, and to better understand the report's conclusions and any other concerns member institutions may have about the Accrediting Commission for Community and Junior Colleges (ACCJC) standards and practices relative to the Task Force Report, the Commission held a Special Meeting in Sacramento, California on October 9, 2015.

Thirteen people gave oral commentary to the Commission, and additional persons sent in written comments. At the meeting's conclusion, the Commission issued a press release (attached) about the value of the discussion for the Commission as it reflects on its practices and considers additional changes to those being implemented this year with the new Accreditation Standards. The Commission also committed to having additional meetings with the member institutions in California in order to provide opportunity for input and discussion of the Task Force Report, or any other input the member colleges wish to provide.

To that purpose, we are writing to announce the first two additional discussion and listening sessions. These, and future sessions planned for after the new year, may be located in a place that is convenient for you to attend, and we hope you will do so.
